### AUSTRIA - 2025



The Horatio European Psychiatric Nurses Association convened its Board Meeting on 13 November 2025 in Vienna, hosted at the Hochschule Campus Wien: University of Applied Sciences (HCW).

The gathering marked an important opportunity for the Board to deepen its understanding of psychiatric nursing in Austria, to exchange perspectives on current developments, and to explore pathways for future collaboration with the Austrian Health and Nursing Association (ÖGKV). The meeting combined expert contributions, strategic dialogue, and reflections on shared ambitions for advancing psychiatric nursing across Europe.

The day began with a formal welcome from representatives of the Hochschule Campus Wien, who emphasised the university's commitment to professional excellence, applied research, and strong partnerships with clinical institutions. They expressed appreciation for the work of Horatio in strengthening psychiatric nursing across Europe and acknowledged the importance of international collaboration in addressing the challenges and opportunities facing the profession.

From Austria, the meeting brought together leading experts and representatives including: Cornelia Schneidtinger, Member of the ÖGKV Federal Expert Group for Psychiatric Nursing Stefan Nöstlinger, Academic Expert Programme for Psychiatric Health Care and Nursing at HCW Gerhard Lindenhofer, Deescalation Trainer, NAGS (Network for Violence Prevention and Safety). This diverse group created an ideal platform for shared learning and the strengthening of cross-national professional ties.

The first expert contribution was delivered by Gerhard Lindenhofer, a renowned specialist in violence prevention and de-escalation. His presentation highlighted key strategies used in Austrian psychiatric facilities to prevent aggression, promote patient safety, and support staff wellbeing. He described Austria's systematic approach to violence prevention, which integrates structured staff training, early recognition of risk factors, and evidence-based intervention models.

Stefan Nöstlinger followed with an overview of the educational pathways for psychiatric nurses in Austria. He provided a detailed explanation of the specialisation programme delivered at the Hochschule Campus Wien, describing curriculum components, clinical placements, and competency expectations. He also highlighted the importance of translating theoretical knowledge into practice and the crucial role of interprofessional education.

.The third presentation, delivered by Cornelia Schneidtinger offered a reflective and forward- looking perspective on psychiatric nursing in Austria. She traced key milestones in the profession's development, from the evolution of psychiatric reform to current efforts supporting patient-centred and recovery-oriented care. Looking to the future, were identified priorities such as expanding community psychiatry, strengthening research capacity, integrating innovative models of care, and further reducing coercive practices. Her presentation resonated strongly with Board members, given Horatio's commitment to promoting humane, evidence-based, and rights-oriented psychiatric nursing across Europe.

Strategic Dialogue: Collaboration Between Horatio and the ÖGKV - The discussion was both constructive and forward-looking, reinforcing the shared belief that professional alliances are essential for addressing the complex challenges that psychiatric nursing faces across Europe.





### **MENTAL HEALTH EUROPE**

Co-creation and Impact Evaluation

Mental Health Europe (MHE) has positioned co-creation as a core principle in its work with members, service users, families and professionals across Europe. As a full member, Horatio represents the voice of mental health nursing within this network and contributes actively to the development and implementation of co-creation tools.

Over the past years, Horatio, together with other MHE partners, has contributed to the development of an MHE co-creation toolkit. The current phase focuses specifically on evaluating the impact of co- creation. Based on a rapid review of existing co-creation evaluation frameworks, Horatio analysed the strengths, gaps and limitations of different models for use in mental health settings.

Based on this analysis, the MHE task force decided to adopt the PROSECO framework as its primary reference and to adapt and operationalise it further for the MHE context. PROSECO comprises five themes and 35 elements. In this phase, the taskforce chose to concentrate first on the theme "Impact" and to add the element "Readiness", reflecting recurring needs identified during trainings facilitated by MHE.

This work has been translated into a structured draft table that includes the original PROSECO definitions and an additional column with concrete criteria, indicators, and guiding questions for practice. The draft has been circulated to taskforce members, inviting them to comment on the definitions and the proposed operationalisation, with feedback requested by the end of the year. Within this process, MHE provides the overall framework and strategic direction, while Horatio contributes expertise from mental health nursing practice, education and research. This collaboration helps ensure that the emerging MHE framework for co-creation impact evaluation is both methodologically robust and grounded in real-world practice, with particular attention to the role of mental health nurses and, most of all, to the meaningful involvement of people with lived experience and their families.



#### Rooted. Resilient. Ready. Fundamentals of Mental Health Nursing Driving the Future

The conference theme this year goes straight to our fundamental roots. There is a sheer complexity to mental health nursing, sustained by the brilliance, creativity, and humanity it requires. Across Europe, we may work in different systems, cultures, and contexts, but we face many of the same challenges. We see, at times, different cracks, but often the same pressure points.

The conference in Belgium is an invitation to share your work, be part of a community of passionate, tireless, and deeply committed mental health professionals and experts by experience from across Europe. # MENTAL HEALTH NURSING LEADERS SUMMIT

Aisling Culhane President and Tomas Petr Treasurer Represent Horatio European Psychiatric Mental Health Nurses as Global Mental Health Nursing Leaders Unite in Barcelona Spain 21–22 November 2025. A landmark summit sets the stage for a new era in mental health nursing leadership. The summit addressed urgent global challenges in mental health nursing, including post-pandemic mental health deterioration, workforce shortages, and the erosion of leadership visibility. Mental health nurses represent 44% of the global mental health workforce, yet face systemic barriers such as limited policy recognition, diluted education models, and legislative gaps.

#### Main Objective:

To Establish an International Congress of Mental Health Nurses (ICMHN) to restore disciplinary self-determination, advocate for universal mental health care, and strengthen global collaboration.

Priority Themes Discussed: Through A World Café Format

- 1. Intersectoral Integration Moving beyond biomedical models to holistic, community-based care.
- 2. Education & Development Reforming curricula, promoting lived experience inclusion, and building academic capacity.
- 3. Workforce Expansion Addressing shortages, retention, and leadership pathways.
- 4. Human Rights & Drauma-informed, culturally safe, recovery-oriented care.
- 5. Technology & Dafe integration of digital tools and ethical frameworks.
- 6. Climate Change Response Preparing for mental health impacts of environmental crises.
- 7. Suicide Prevention & Transformative Kindness Innovative, person-centred approaches.



#### Next Steps:

- Adoption of the Barcelona Declaration of Priorities.
- Formation of a working party to draft terms of reference for ICMHN.
- Post-summit Delphi survey to rank priorities, followed by a global communiqué in the International Journal of Mental Health Nursing.

#### Looking Ahead

This summit marks a turning point for mental health nursing leadership—enhancing visibility, shaping policy, and ensuring future-ready strategies for global mental health care. While several attendees, including Associate Professor Sevil Yılmaz and Assistant Professor Özge Süküt, described the summit as "a dynamic forum addressing human rights, safe environments, and ethics",








### **EU PROMENS**

#### **Horatio Fellowship Award**

As announced at the Annual General Meeting in May 2017, the Horatio Award will recognise recipients for their contribution to the professional activities in support of psychiatric/mental health nursing (PMHN), either in Europe or worldwide. It is designed to ensure that those who have had an extraordinary influence on the professional growth, development, and identity of PHMN will be rewarded for their endeavours. The first to receive the award in 2017 was Mr. Des Kavanagh who, throughout a long and active career, had been highly influential representing PMHN in Ireland, and for nine years was the first President of Horatio.

#### Award Process

Only full, paid up, member organisations of Horatio can nominate one person per year using the attached form. It can either be one of their own nationals, or someone they wish to recognise from another country. Nominations are not restricted to European nurses only but may be from worldwide. There are no specific criteria that need to be met, but the individual must have demonstrated over time a commitment to their own work and that of PMHN. Nominations should be sent to the General Secretary of Horatio by the closing date on the form. All nominations must be accompanied by the signed Nominee Consent Form.

#### Award Selection

The recipient will be the individual who, in the opinion of the Board members, has demonstrated the qualities necessary to receive this prestigious award. In the event that the Board is unable to agree upon a successful candidate, more than one Fellowship may be awarded for that year, though this is to be avoided if possible. In the event that the Board does not feel that the nominations meet with the high standard set for the award, no Fellowship will be offered that year. Nominating organisations will be advised of the Board's decisions in advance of the award presentation.

#### Award Presentation

The award will be announced and presented at the next Horatio Congress or Festival. Whilst it is preferable, the recipient does not have to be present at the event. In the case of an absent recipient a nominated person/organisational representative, may receive the award on their behalf. The Fellowship is awarded for life and the Fellow's name will appear on the Horatio website, along with the announcement of their award and short biographical details about the individual. (In very extreme circumstances, and at the discretion of the Horatio Board, a Fellowship may be withdrawn).
